## Cabinet expanded in Telangana

- Telangana CM K.Chandrasekhar Rao increased the size of his Cabinet, inducting six more ministers. The new ministers include KTR, T. Harish Rao, who both served as ministers in Rao's cabinet in the first tenure of his government. Now, the KCR Cabinet has 18 ministers, the most in proportion to the number of MLAs in the Assembly. The latest Cabinet expansion marks the first ever entry of two women ministers in the KCR government. Of the two women ministers, Sabita Indra Reddy, and Satyavathi Rathod.

## Welfare given priority in Telangana Budget

- Telangana Chief Minister K Chandrasekhar Rao presented the annual budget for 2019-20 in the Legislative Assembly. He presented an annual budget of Rs 1,46,492.30 crore of which he stated that Rs 1,11,055.85 crore was allotted for revenue expenditure while Rs 17,274 crore was allotted for capital expenditure. This is 19.5% less than the vote on account budget. The fiscal deficit of the state has been projected to be Rs 24,081.74 crore and revenue surplus to be Rs.2,044.08 crore. According to Budget speech the State's Gross Domestic Product (GSDP), stood at Rs.8,65,688 crore for the financial year 2018-19, had more than doubled since Telangana's formation.
